- to analyse errors/accidents, to promote the improvement of safety conditions and the physical and psychological wellbeing of its employees as well as the reduction of the significance of environmental aspects with effective preventive and corrective actions; to reduce any risk, including that of biological contagion
- the involvement of all suppliers of goods, activities and services and to guarantee their commitment to social responsibility and the environment by complying with all the requirements of the relevant standards;
- the respect and support of its declaration of principles of Social Responsibility;
- to involve all personnel, stakeholders (in particular suppliers) and all interested parties by disseminating the Policy, the principles of social responsibility and the results expected and obtained from the Social Accountability System and the Environmental Management System, keeping continuous channels of communication open to the outside world

- avoid conflicts of interest;
- not tolerate money laundering and the financing of terrorist activities;
- apply appropriate due diligence that takes into account the risk associated with the counterparty before entering into any business relationship and closely monitor our supply chain and exercise Know Your Counterpart activities;
- fully and thoroughly disclose the characteristics of the precious metals sold and ensure the weight, functionality, finish and title of its products, guaranteeing their conformity and quality through systematic controls with effective, state-of-the-art precision instruments
- adopt appropriate systems and measures to ensure the integrity and security of product shipments and to prevent theft, damage and substitution;
