### STEP 1: ESTABLISH STRONG COMPANY MANAGEMENT SYSTEMS

**Chimera Gold srl** have the following policy in place, *Company Policy rev4 dated 09/04/2024* with regard to our supply chain on the following minerals: *gold, silver, platinum group metals, diamonds* originating from conflict-affected and high-risk areas. This policy is communicated to our suppliers and stakeholders by distributing them via website link *https://www.chimeragold.com/sostenibilita-2/* or e-mail, these policies can also be accessed by our internal stakeholders via notice boards were all policies are present.

To support supply chain due diligence, we have implemented the following internal measures:

- Suppliers Risk Assessment
- Company Policy
- RJC Manual
- Annual Review

The senior manager responsible for overseeing supply chain due diligence is *Eleonora Anselmi as RJC Responsible*.

**Chimera Gold srl** have established a system of controls and transparency over our supply chain; which include, our approach for identifying suppliers and identifying sources of our precious material materials. All precious metal materials suppliers are listed in our Risk Assessment where is identified:

- Supplyer name
- Supplyer addresses
- Forniture
- Certifications
- Risk level

As a company we communicate our expectations regarding supply chain due diligence by sending to our precious metal materials suppliers via e-mail our *Company Policy* and our *Supplier Disclousure* to be signed. In addition to this we also take audits to strengthen our engagement with suppliers; the outcome of doing so has been very positive, all our suppliers are RJC certified and accepted our policies; the risk of our supply chai is <u>LOW</u>.
